 - i. 1 - 28 days prior to the date booked the full bond will be retained
 - ii. 28 days or more, the bond will be refunded except for bookings between 15th November & 25th December
 - iii. Bond payments are non-refundable for bookings between 15th November & 25th December
5. If less than 50% of the expected number of guests attend the event, the bond will be retained to cover staff wages and operating expenses
6. Themed events must be approved in writing prior to the function.
7. No outside food (with the exception of cakes) or beverage may be brought into Bar Cleveland
8. Bar Cleveland reserves the right to refuse entry to any persons deemed intoxicated, inappropriately dressed or behaving in an offensive manner.
